WHEREAS the Financial Assistance Program from the Road Safety Fund (PAFFSR) aims to financially support initiatives and projects that improve road safety and assist road victims.

WHEREAS the members of the council have reviewed the terms and conditions of the Financial Assistance Program from the Road Safety Fund (PAFFSR).

WHEREAS the members of the council agree to comply with the terms and conditions of the Financial Assistance Program from the Road Safety Fund (PAFFSR).

WHEREAS the aforementioned project, submitted under this program, is estimated at \$210 460.36 including all taxes, and the financial assistance requested from the Ministry is \$146,439.00.

WHEREAS Director General Crystal Webb authorizes the submission of the financial assistance application, confirm its financial contribution to the project, and authorizes one of its representatives to sign the application.

THEREFORE it is moved by Bill Hobbs, that the council of the Municipality of Shawville authorizes the submission of an application for financial assistance; confirms having read and understood the terms and conditions of the program, and confirms its commitment to carry out the eligible project in accordance with the applicable terms, recognizing that failure to comply with them will result in the termination of the financial assistance; certifies that the Director General Crystal Webb is duly authorized to sign any document or agreement, including the financial assistance agreement, if applicable, with the Minister of Transport and Sustainable Mobility. Carried unanimously.

WHEREAS the Council of the Municipality of Shawville has reviewed Estimate No. EST329 submitted by Jason Hynes Construction.

WHEREAS the total cost of the estimate is \$44,782.76, taxes included.

WHEREAS the work covered by this estimate includes, if required:

- Removal and replacement (R&R) of asphalt through saw cutting and removal.
- Supply of stone (if needed).
- Fine grading of the area to achieve proper slope; and
 - Supply and placement of 50mm of commercial ESG-10 asphalt with proper compaction.

WHEREAS resolution #82-25 was passed June 10, 2025, that Jason Hynes Construction will provide patching services exclusively for the 2025 calendar year.
